During the presentations the participants were involved in talks strengthening information and knowledge accumulated on terms and definitions, standards and principles, collection development policies, as well as using the electronic questionnaire generated by Survey Monkey.

Finally, the participants completed the Evaluation Form of Module Library Collections Development Policy, giving a maximal score for well- prepared presentations, clear explanations of the subject, excellent trainers connection with participants etc.
